What To Bring

- Photo Identification
- Social Security Cards and birthdates for all listed on tax return.
- ALL income documents (W-2, 1099, W-2G, 1099-INT, 1099-DIV)
- Total Amounts of itemized deductions (charitable contributions, auto taxes paid, other property taxes, etc.)
- For direct deposit of refund, bank documents showing routing and account numbers.
- Total Amount paid for child dependent care & providers ID or SS Number
- 2010 Tax return
- To file a "married filing joint" return electronically, both spouses must be present to sign forms
- Schedule CEZ & Schedule C with expenses up to \$10,000 can be prepared as long as the income meets the VITA guidelines of \$50,000
