Committee Reports

Real Estate Committee

David Dillard provided the following updates:

- Pineville Update
 - We anticipate opening in the fall to the public and will plan for a few weeks of soft opening before we have a grand opening event.
 - The Town of Pineville plans to occupy the second floor of the municipal offices and their town hall space so in early August the lobby will be complete, and the upstairs will be complete, and they are planning for some kind of ribbon cutting ceremony and we will plan to have some library staff on hand for that.
 - The library's interiors are completed including carpet, paint, millwork, lighting etc.
 - The opening day collection has been selected and ordered along with the furniture and AV equipment.
- University City Update
 - Making good progress negotiating final terms of all the agreements
 - We have extended our lease with the hospital authority so will not have to close the UC branch before the new location opens.

CEO Report

Marcellus Turner provided the following updates:

- Emery Ortiz will be joining us at our next Board of Trustees meeting as our new Chief of Strategy and Innovation.
- Industry Update- ALA Conference Take Aways
 - Several of us were able to travel to Washington DC to participate
 - Major topics included:
 - Equity and Diversity and Inclusion (EDI)
 - Review of policies and practices around book banning and protests
 - Critical Race Theory

The board discussed how other library systems are addressing EDI. We are farther along than many systems in that our task force has already met and created recommendations. Other conversations included how CM Library handles book banning requests and protests. Mr. Turner agreed to provide the protocol for both of these issues to the Board.

- Mecklenburg County's Equity, Diversity and Inclusion Efforts
 - Angie Myers provided the following highlights:
 - Mecklenburg County has hired LaShaun Carter to lead the County's efforts around EDI.
 - Mr. Carter has fully embraced the County's equity vision and mission statements

- He is also looking to build on the principles of the Government Alliance on Race and Race Equity using other credible models
- He has tiered his work with county departments and agencies and the Library is in tier 1 which is an acknowledgement of a lot of good work the Library has already done.
- He will work with the County's existing Equity Action Plan and create a 2.0 version
